COMMUNIQUE TO STAKEHOLDERS OF ERSTWHILE KZNLA AND KZNGBB

RE: Establishment of the KwaZulu-Natal Economic Regulatory Authority (KZNERA)

We write to inform you of recent developments following a Cabinet Resolution which was taken regarding the rationalization of the KZN Gaming and Betting Board (KZNGBB) and the KZN Liquor Authority (KNZLQA). This resolution has led to the establishment of the KwaZulu-Natal Economic Regulatory Authority (KZNERA).

The KwaZulu-Natal Economic Regulatory Authority Act (Act 1 of 2024) has been successfully processed by the Department and was gazetted by the Provincial Legislature on May 24, 2024.

The legislative mandate of the KwaZulu-Natal Economic Regulatory Authority is to provide for the regulation and economic empowerment of the liquor and gambling industries in the province of KwaZulu-Natal. The legal mandate of the KZNERA is to implement both the KZN Liquor Licensing Act No. 6 of 2010 (Liquor Licensing Act) and the KZN Gaming and Betting Act No. 8 of 2010 (Gaming and Betting Act).

In line with these developments, the Department of Economic Development, Tourism and Environmental Affairs has appointed the interim Board of Directors and interim CEO, marking the conclusion of the existing entities and the official initiation of the new entity.

The former KZNGBB Offices in Pietermaritzburg are functional for stakeholders to engage.


